"Retain until final minutes are approved or administrative use ceases, whichever occurs later. Includes any audio or visual recording of a meeting by the public body or authorized by the public body. This includes recordings by public bodies to use as an aide in drafting the final version of meeting minutes. This does not include recordings made by persons attending the meeting who wish to record a meeting for their own purposes."

3. Public Meetings are held upstairs but if a resident with disabilities shows up the meeting would be moved down to the bay where our Annual meetings are held.

Dear Christian Tobin:

We understand that on August 13, 2024, you filed a complaint with the Dalton Fire District ("District") alleging a violation of the Open Meeting Law, G.L. c. 30A, §§ 18-25. The District is required to notify our office of the complaint and any remedial action taken to address the complaint. G.L. c. 30A, § 23(b); 940 CMR 29.05(5). Our office received notification and a response from the District on August 24, 2024.

Under the Open Meeting Law, our office may only review your complaint after 30 days have passed from the time you first filed your complaint with the District. G.L. c. 30A, § 23(b); 940 CMR 29.05(7). After 30 days have passed since you filed your complaint with the District, you may file a request with our office for further review of your complaint.

Thirty days have now passed since you first filed your complaint with the District. You may file a complaint with our office for further review up until 90 days have passed since the alleged violation date. If you wish to request further review of your complaint, we must receive your request for further review and a copy of the initial complaint by **November 6, 2024**. If we do not receive a request from you for further review by that date, we will presume that the action taken by the District was sufficient and will close the file.
